

AXALTA RAPTOR SWEEPSTAKE - TERMS AND CONDITIONS

IDENTITY

This competition is organised by Axalta Coating Systems EMEA Holding B.V., having its registered offices at De Geer 14, 4004 LT, Tiel, the Netherlands, ("**Axalta**").

WHAT IS "AXALTA RAPTOR SWEEPSTAKE"?
